Pool Signs: New signs regarding keeping the gate closed have been placed on both sides of the gate. They are there to remind all members and guests that the gate needs to stay closed at all times, even during parties. unless entering or exiting. This is for our insurance.

Litter: When you leave the pool, look around for your trash and help get it in the trash bin. Napkins, Paper Towels, Nut Shells, Cups, and other small or easily wind-blown items are often found littering our pool.

Pool Parties: Available M-Th from 7-10pm. Free for groups smaller than 25 with refundable deposit. In an effort to make parties safer, there are some additional party rules taking affect this year: Max site capacity is 62 persons. A party must have a 1:12 lifeguard to party attendee ratio or better. Proof of lifeguard procurement required one week prior to party. Contact Heidi to schedule.
