Pool Temperature: The board continues to struggle with finding a pool temperature that fits everyone's comfort level. In recent years the temperature was raised from 80 to 82. Everyone was happy with this change. This swim season we tested 84. While some members were happy, other members, who were unaware of the test, mentioned that the water was too warm. In 2017 we will run an unannounced test at 83 degrees and see how that is received.

Off-Season Maintenance: Every year there is a long list of maintenance and repair tasks that the pool needs in order to keep it in good condition and passing health inspections. The 2016 season was no exception: back flow valve, outdoor lights, storage room door, etc. Below is a partial list of outstanding repairs. - Place ground cover on street strip
- Replace hinges on chemical room
- Coat bathroom floor with sealer
