



## NOTICE: POOL PARTIES

We have had a number of problems with pool parties this swim season, so we wanted to reiterate the rules

in a bold fashion:

- 1) There are **NO** parties on weekends. Parties are only allowed M-Th 6-10pm with a reservation.
- 2) Parties with 25 or more people require lifeguards.
- 3) The max site capacity is 62.
- 4) A deposit is required, extra fees for chemicals may also be required.

These rules are for the greater good: they minimize liability, meet health standards, adhere to the city's conditional use permit, and mostly allow the pool to be used by all its members.

**Cleaning Up:** We've had a number of weekends where the pool has been left a complete mess (toilets unflushed, toys everywhere, trash littered). Everyone needs to clean up after themselves. If we continue to have messes, then we will need to raise rates to cover the need for daily janitorial services.

**Maintenance Vendors:** This swim season we switched our pool maintenance provider of perhaps 15 years. Our new pool guy has spent many hours on needed repairs and replacements to help the pool run more efficiently.

Last year we piloted having local teens provide janitorial cleaning support for the pool. This year we've gone back to a professional supplier.

**Work Party:** We had 23 families supporting this year's work day. We appreciate everyone's contribution and hope that we can have more attendance in the future. (Note, in 2016 we also had 23 families attend the work party).

### Other Safety Items:

- Watch your children at all times.
- Poop in the water? Close the pool and call a board member.
- Encourage your kids to be safe by not moving tables, not running, responsible jumping, etc.
