## Major Off-Season Maintenance:

This past swim season we experienced abnormal water-loss from the pool an indication of a leak. Because we had to so often refresh the water levels we had difficulty keeping the proper amount of chlorine in the pool. This resulted in a few algae blooms, one which was a difficult-to-kill strain.

In order to kill this algae properly, the pool needed to be drained and the walls scrubbed. This was also an opportunity to check the pool for leaks.

When we drained the pool we found bubbling plaster (which is the cause of the leak), and aging / cracking water-return pipes. These items will need to be repaired.

When this work is done on the pool we may be required to bring the pool up -to code on things that have been grandfathered in according to the old standards. We are checking on these considerations to confirm exactly what needs to be done while we have the opportunity to make changes.

We are currently in the processing of finalizing exactly what work needs to be done. Once that is complete, we will get multiple bids. We will let you know what results we find, possibly in a off-cycle letter to the members.
