New Kirkwood Leadership: At the Nov 12th meeting, elections were held for the President, Vice President, and Secretary positions. As a result of the election, we have a new President, Lea Stivaletti. Lea was previously serving as Vice President. She replaces Rick, who served a president for many years and leaves a strong legacy of service. We also welcome Jeff Poppinga as our new Vice President (replacing Lea). Jeff has always been an enthusiastic support of the pool club - last winter he rebuilt the pergola, this winter he has already tackled a number of projects outlined later. Finally, Julie Mills was sustained in the Secretary role for another term.

Membership Count: The membership approved a measure to increase the number of owners from 85 to 90. Each additional membership is being sold for \$2,000. These expect to be sold by the end of the calendar year.

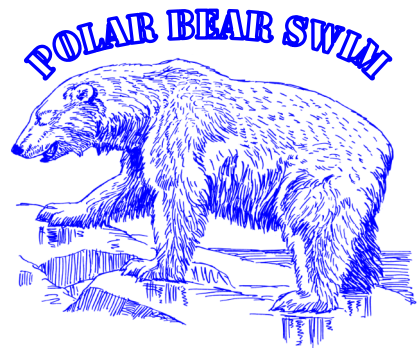
Confirmation of Pool Capacity: Per request at the annual meeting, the city confirmed in-pool capacity at 55 people.

Offseason Maintenance: Work has begun on all the off-season work to keep the pool in shape. Most recently, a small fence job to keep kids from running behind the pool house has been erected on either side of the pool. Replumbing to the pool house, including replacing water heater, is in progress. Perimeter fencing is being fortified, with option to replace the fence shared with neighbor.

Pool House Roof: We've selected one of the three different bids to replace the roof of the pool house. The roof should be completed by the end of the year.

Website: There is a Kirkwood Pool Club website that covers the basics of pool information: latest splash, by-laws, rules, etc. We are evaluating options for the Facebook page. Feedback on the site welcome. kirkwoodswimclub.weebly.com/

Pool Insurance: The question of insurance coverage was brought up at the annual meeting. To ensure adequate coverage and competitive rates, we have solicited bids for insurance coverage from a few carriers. This remains a work in progress.
